- 1. Information about use of our cookies
 - 1.1. Our website <u>www.equiti.com/scv</u> uses cookies to distinguish you from other users of our website.
 - **1.2.** This helps us to provide you with a good user experience when you browse our website and also allows us to improve our site.
 - **1.3.** By continuing to browse the site, you are agreeing to our use of cookies.
 - 1.4. A cookie is a small file of letters and numbers that we store on your browser or the hard drive of your computer after you agree to such use. Cookies contain information that is transferred to your computer's hard drive.
 - 1.5. We use the following cookies:
 - (i) Strictly necessarycookies: These are cookies that are required for the operation of our website. They include, for example, cookies that enable you to log into secure areas of our website. Without these cookies, services you've asked for (such as access to secure areas) can't be provided.

These cookies will not gather any information about you that could be used for marketing, or remembering where you've been on the internet. This category cannot be disabled.

- (ii) Analytical/performance cookies: They allow us to recognise and count the number of visitors to our website and to see how visitors move around our website when they are using it. This helps us to improve the way our website works, for example, by ensuring that users are finding what they are looking for easily.

These cookies are not used to target you with online advertising. Without these cookies we are unable to learn how our website is performing and make relevant improvements that could improve your browsing experience.

- (iii) Functionality cookies: These are used to recognise you when you return to our website. - 1.7. You may block cookies by activating the setting on your browser that allows you to refuse the setting of all or some cookies. However, if you use your browser settings to block all cookies (including essential cookies) you may not be able to access all or parts of our site.
- **1.8.** If you've disabled one or more cookie categories, we may still use information collected from existing cookies, but we'll stop using the disabled cookies to gather any further information. You can delete existing cookies from your browser.
